**ASX ANNOUNCEMENT**

**SHARES ISSUED TO OUTOKUMPU MINING OY**

The Share and Loan Sales Agreement ("Agreement") between Dragon Mining and Outokumpu Mining Oy ("Outokumpu") for the acquisition of Outokumpu's precious metals assets in Finland signed in October 2003, included an obligation of the payment of €1,000,000 in cash or shares when 100,000 ounces of gold was produced from any of the gold projects acquired.

The Orivesi Gold Mine achieved the production of 100,000 ounces of gold in March 2011, and in accordance with the Agreement the payment has been satisfied by issuing 892,105 ordinary fully paid shares in Dragon Mining at a price of \$1.52 a share. The issue price was based on a predetermined formula outlined in the Agreement and at the exchange rate on the date the payment became due.

There are no further contingent or performance based payments owing to Outokumpu as part of this Agreement. Outokumpu retains 2.5 million shares from the 2003 transaction.
